#### 1. MAPPING YOUR VISIT OF OUR WEBSITE

#### A. Cookies

- i. A cookie is a small text file that is stored by the browser of your computer, tablet or smartphone when you first visit this website.

- A.i.a <u>Functional cookies:</u> These are cookies with a purely technical functionality. These ensure that the website works properly, so that it can, for example, remember your preferred settings. Using these, we can also optimize our website and the services through our website.
- A.i.b <u>Analytic cookies</u> by third parties: These cookies can keep track of your online behaviour. These cookies are used by Google Analytics.
- A.i.c <u>Tracking cookies:</u> These cookies are placed by an external party. By reading these cookies the advertiser recognizes you when you visit a site in which he is also involved. If you continue browsing, personalized ads can be shown. These cookies can also keep track of your online behaviour, which may result in a very specific profile being built by these parties. This profile can be so detailed that it is considered personal data.

- i. We have already informed you about these cookies and asked permission for their placement on your first visit to our website.
- ii. You can disable cookies by configuring your internet browser so that it no longer saves cookies. # 3. GOOGLE ANALYTICS

#### A. Google
